SINGLE WINDOW CLEARANCES FOR INDUSTRIES OF TELANGANA STATE

To encourage the investors for quick implementation of their projects and to streamline the regulatory processes at a Single Point, the Government of Andhra Pradesh have enacted the "Industrial Single Window Clearance Act No.17 of 2002" to process and issue various approvals / clearances / permissions required to set up an Industrial Enterprise. Single Window services for industries is a concept to provide all entry level services to entrepreneurs, with minimum interface with departments, in a transparent manner, within specified time leading to hassle free approvals. There is a provision for deemed approvals for certain clearances.

Under the Single Window Act, Government have notified and constituted different Agencies /Committees for receiving, processing and monitoring of applications under Single Window Act.

The **Single Window Clearance System** Portal is a **single window** facilitation mechanism for investors. It provides manuals to help investors understand the application process for proposed investment projects.

At Aurora's P.G. College, Moosarambagh, a One Day Seminar was conducted on 24th June, 2016 on the theme "Single Window Clearances for Industries of Telangana State".


